### TERM AND CONDITIONS OF SALES

- This special promotion not included CA & GA sales tax, shipping & handling charge and any special installation charge.
- IPTV Set-top-box(s) are at all times property of Atlanta DTH Inc.
- Subscriptions billing period shall commence on the 1<sup>st</sup> or the 16<sup>th</sup> day of each month, and end on the 15<sup>th</sup> or the last day of each month.
- ADTH will activate subscriber account within five working days upon receipt of subscription fee. Should any problem arise in receiving the program, please contact your local dealer or ADTH immediately. Subscriber agrees to inform ADTH in writing of any change of decoder or billing address two weeks prior to the change.
- Subscriptions Renewal invoices will be sent to subscriber billing address 1 month before subscriptions expiration date. Subscriber accounts that are past due 5 days after the expiration date are subject to deactivation. A US\$25.00 fee shall be charged to subscribers whose accounts have to be reactivated due to deactivation.
- Programming contents is the property of all content providers and subscribers agree not to use any part of the programming for rebroadcasting or any other commercial purpose without prior consent of all subscription channels.
- Failure to observe and comply with the clauses of this agreement may result in termination of the subscriptions.
- All content providers or ADTH shall not be responsible for any disruption of the reception of all subscription channels program due to technical problems, civil disobedience, force majeure or any other reason beyond the control of all content providers or ADTH.
- Upon completion of the contract period under the Programming Order Agreement, subscriber may choose any other package available at that time.
- This special promotion is valid until February 28, 2018. ADTH reserves the right to revise the terms, conditions and channels of the promotion without prior notice.

### MERCHANDISE:

- Warranty: ADTH warrants to the original purchaser of the merchandise a limited 12-month warranty from the original purchase date.
- Return Merchandise Authorization (RMA): Whenever warranty service is needed, purchaser should first contact with ADTH. If the merchandise is purchased directly from ADTH, the purchaser should
  - Call customer service for an RMA # before returning any merchandise. RMA # is good for 14 days only.
  - Returned merchandise must be shipped freight prepaid and insured (strongly advised) by the customer. ADTH will not be responsible for any return shipping charge and any lost or damages for such returned product.
  - Returned merchandise must come with a copy of the original purchase invoice and a complete description of the problem encountered by the customer. Customer should also mark the assigned RMA # LEGIBLY on the outside of shipping carton. ADTH warehouse will refuse any packages that come without such RMA#.
- Credit/Refund: Merchandise may be returned for credit within 10 days of the original purchase date and after a restocking fee of US\$60.00. All merchandises returned for credit must also satisfy the following conditions: (a) be in LIKE-NEW and in resalable condition in its original package; (b) should not have any making or appear to have been used; (c) should be returned with all manuals and accessories. Additional deductions will be charged if items are missing from the original package. Refund checks will be mailed out 10-14 days after merchandise is received, tested, inspected, and approved by ADTH. Shipping and handling charges for any merchandise return are non-refundable.
